2. **You have use of the facility for two hours.**
3. **Cheese pizza, water, juice boxes and all table settings, paper goods included for 8 children (Additional children \$7/Child).**
4. **Parents will be invited to attend the final 15 minutes of the party for their children's performance of the routine they will learn.**
5. **As a friendly reminder we recommend parents socialize in the lobby during the dancing portion of the party, as it is a distraction to some kids to allow all the parents in the dance room. Parents will be able to watch a performance the last 15 minutes of the party.**
6. **Birthday cakes are the host's responsibility as well as any additional food or drinks. No alcohol.**
7. **Each child will participate in dance themed games, a fun dance warm up, and a performance. A Certificate of Excellence for each child will be provided and a group photo will be emailed to the host after the party.**
8. **Any additional treats, goodie bags, decorations, or other special additions need to be dropped off the day before the party or several hours prior.**

Please take into consideration that when you book a party, you are bound to your time slot. If you arrive late, we cannot extend the end time of your party. You may arrive 15 minutes prior to event time but no sooner.

**Cancellation Policy:**

In the event that you choose to cancel your party, you must call one week prior to the date in order to receive a refund of 75%. If you cancel any time after that you will be charged the full amount.
